Although outdoor transmission of COVID-19 is known to be lower than indoor transmission, enforcing physical distancing on an outside playground is difficult and may not be the most effective method of risk mitigation according to the Academy of Pediatrics.

Our staff will place an emphasis on maintaining consistency with student grouping and limiting the size of groups participating in activities on the playground each day. Staggered schedules of grade levels will be utilized to support these efforts.

All students and staff will be required to use hand washing and/or alcohol-based hand sanitizer before entering the playground and upon exiting the playground.
